Fall and winter rains have soaked the San Jacinto Wildlife Area and hopefully there will be a good show of flowering plants and wildflowers to see this year. There are many wonderful scenic views to see from the wildlife area: Mt. San Jacinto in the distance, green hills in The Badlands and adjacent Lake Perris State Recreation Area. We urge you to take time and visit the wildlife area, enjoy the views, the wildlife, and the solitude.

While you are visiting take time to remember that even though there is a slump in the housing market, Riverside County, Moreno Valley and other cities are working to approve housing and commercial development which will encroach on the wildlife values of the San Jacinto Wildlife Area. The Friends of the Northern San Jacinto Valley have been working since 1991 to comment, meet with, and encourage local decision makers to respect and value the wildlife area. Putting developments on the boundary of the San Jacinto Wildlife Area will significantly reduce its value as a Multi-Species Habitat Conservation Plan reserve, Stephens' kangaroo rat reserve, and mitigations lands for the State Water Project. Please take time to read our articles and reflect on how important it is to protect this wonderful habitat.

### SAN JACINTO WILDLIFE AREA News:

SAN JACINTO LAKE CHRISTMAS BIRD COUNT, December 2007 by Tom Benson, Compiler, San Bernardino Valley Audubon Society: The San Jacinto Lake Christmas Bird Count was held on Tuesday, December 18, 2007. The total tally was 147 species with one party not yet reporting. Highlights included: Common Loon (Lake Perris), Horned Grebe (Lake Perris), Snow, Ross', and Cackling Geese, Eurasian Wigeon, Bald Eagle, Golden Eagle (San Jacinto Wildlife Area), Lesser Yellowlegs, Marbled Godwit, Thayer's and Glaucous-winged Gulls (Lake Perris), Gray Flycatcher, and Eastern Phoebe (San Jacinto Wildlife Area west of Davis Road). Thanks to all who participated and made this a successful count.

ONGOING EFFORTS FOR THE BURROWING OWL by Ginny Short: The Statewide Survey for Burrowing Owls was concluded last year. We expect to hear from the Institute for Bird Populations at any time regarding their results. Thanks to everyone who participated. You can go to: <a href="http://www.birdpop.org/">http://www.birdpop.org/</a> for more information. We will be doing burrowing owl surveys on the San Jacinto Wildlife Area and hopefully Lake Perris. The drought last year had a drastic effect on breeding, so hopefully we will

see some improvement this year. If you find burrowing owls anywhere on the wildlife area or anywhere in Riverside, please contribute to our burrowing owl database. We need to know where (coordinates are best, or clear description), how many, and when (date and time). Please forward any information to Ginny as above. Happy Owling!

<u>UPDATE ON BLUEBIRD BOXES</u> by Sue Nash: Fourteen of the original fifteen bluebird boxes placed at the San Jacinto Wildlife Area are still in place. The Friends will continue to clean and monitor them this spring. Last year the boxes were basically not used because of the drought. We hope our next newsletter will include reports of many nests, baby swallows, and fledging birds. Join us on our March 15 walk to personally inspect them. ### FRIENDS' NEWS & PROJECTS:

UPDATE ON CEQA LAWSUIT FILED BY FRIENDS REGARDING THE SJWA WETLANDS RESTORATION PROJECT by Sue Nash: The lawsuit filed by the Friends in August 2007 has a court hearing set for February 22, 2008. The events which occurred at the San Jacinto Wildlife Area which precipitated our filing the lawsuit stem from: a lack of good management of the wildlife area by Department of Fish Game (DFG) and the failure of DFG to avail themselves of the accumulated knowledge of the SJWA of Friends, other local environmental groups, and biologists. It appears that for DFG (the agency entrusted with protecting our wildlife resources) the mere appearance of compliance with the laws found in the California Environmental Quality Act (CEQA) and the Fish and Game Code was sufficient.

In brief, we first allege that before approving a project to move 650,000 cu. ft. of soil on 500 acres to create hunting ponds, the Wildlife Conservation Board (a division of DFG) was required by law to have a CEQA document before them which identified and mitigated the many significant negative environmental impacts of the project. Second, the negative declaration prepared by DFG was prepared months after the project was approved and failed to identify, let alone mitigate, any of the significant negative environmental impacts of the project. Third, DFG failed to even investigate or enforce apparent violations of the F & G Code which resulted when burrowing owl nests were buried and no streambed alteration permit was obtained.

TWO NEW USES OF RECLAIMED/RECYCLED WATER AT THE SJWA by Sue Nash: 1) On November 30, 2007 the California Department of Public Health sent a letter regarding the use of recycled water on the San Jacinto Wildlife Area to the Santa Ana Regional Water Quality Control Board and to

Eastern Municipal Water District and Elsinore Valley Municipal Water District. Until this letter was written, recycled water could NOT be ponded on the SJWA in the flood plain during the flood season. This was in order to protect the quality of drinking water in Canyon Lake. Now, recycled water may be used on all locations on the SJWA, year round. The letter will be posted on our website <a href="https://www.northfriends.org">www.northfriends.org</a>

Friends are not necessarily opposed to this action, but we are concerned that EMWD denied the existence of this letter after several inquiries were made by the Friends after the November 30, 2007 date. In addition, the public was **NOT** notified about this change and a CEQA document was not prepared, even though there potentially could be significant impacts to water quality and public health.

2) In January 2008, a private consultant, K. S. Dunbar Associates, issued a Notice of Preparation (NOP) of a Draft *Program* EIR for Eastern Municipal Water District (EMWD) and the U.S. Bureau of Reclamation (but not for Department of Fish & Game).

The Friends and the public generally were not notified of this document. One of the three projects is the San Jacinto Wildlife Area Recycled Water Storage Project. Eastern proposes to construct a 200 acre lined pond, 20-30 ft. deep, on the SJWA. RIVERSIDE COUNTY GENERAL PLAN 2008 UPDATE by

Sue Nash: The Riverside County General Plan, which was enacted in 2003, is required to be "updated" every five years. When we searched the County web page for information on the General Plan Update, the only reference we could find regarding the "update" was a Notice to Landowners. It stated that those seeking a Foundation Component Amendment to the General Plan must submit a written request to the Planning Department between January 2, 2008 and February 15, 2008 (along with a general plan amendment application and \$8,000.00). If this process proceeds unquestioned, the Villages of Lakeview and other projects surrounding the San Jacinto Wildlife Area will be able to smoothly proceed with their EIR without incorporating a publicly reviewed General Plan Amendment to change much of their land from agricultural to high density residential.

The Friends e-mailed the County Planning Director Ron Goldman regarding the lack of a public input process for the general plan update and the need to include a Global Warming and an Environmental Justice component to the update. The Friends have not yet received a response, but we will continue to pursue this question with the Riverside County Board of Supervisors and the Planning Director.

NOTICE OF PREPARATION OF AN EIR FOR THE LAKE-VIEW/NUEVO AREA MASTER PLAN FOR WATER, SEWER AND RECYCLED WATER by Sue Nash: In October 2007, the Eastern Municipal Water District (EMWD) issued a Notice of Preparation of an Environmental Impact Report (EIR) to install a water, sewer and recycled water system in the Lakeview/Nuevo area. This system, if built, would install the pipes and other facilities to supply the Villages of Lakeview (VOL) project (and other projects in the area) with all of its water, sewer and recycled water needs. The Friends wrote comments objecting to the project on the basis that EMWD only considered the impacts of the physical pipe being laid; EMWD failed to consider the cumulative and growth inducing impacts of the thousands of homes that will easily be built once the pipes are in place. Many of the homes in the Villages of Lakeview project are located on the southern boundary of the San Jacinto Wildlife Area (within 150 feet).

The proposed housing project will have a significant negative environmental impact on the SJWA and the approximately 140 species which the SJWA is supposed to be protecting. (The San Jacinto Wildlife Area is a cornerstone reserve in the Riverside County Multi-Species Habitat Conservation Plan, a county wide system of reserves which, in theory, are supposed to protect Riverside County' endangered plants and animals. Under the MSHCP developers pay for lands to protect endangered species and are in turn allowed to destroy habitat on the land they develop.) Therefore, any piece of any project which will impact the SJWA in the long term, must legally take those impacts into account in its EIR analysis.

PROPOSED VILLAGES OF LAKEVIEW (SP342) by Ann McKibben: The Villages of Lakeview Specific Plan is still making its way through the Riverside County planning process. The applicant hopes to release the Draft Environmental Impact Report (DEIR) by mid-summer and are hoping for a mid-October 2008 hearing on the project. As a reminder, the VOL project proposes to locate approximately 11,000 units (homes, high density apartments) in Lakeview and Nuevo. Approximately, 3,000 units will be located on 350 acres on the southern boundary of the San Jacinto Wildlife Area. A school will be located adjacent to the floodplain between the wildlife area and the Ramona Expressway. Seasonal hunting takes place in the southern portion of the wildlife area and field training for hunting dogs also takes place along the north side of Marvin Road. Both of these uses will be significantly impacted if this project goes forward. Also, Riverside County is planning on expanding the Ramona Expressway to a six to eight lane highway through Lakeview and Nuevo so the northern portion of this project plans to squeeze 3,000 dwelling units of this project, a school, freeway entrances and exits between the Ramona Expressway and the southern boundary of the SJWA.

PROPOSED McANALLY ENTERPISE CHICKEN RANCH (CUP3512) by Ann McKibben: In order to build the Villages of Lakeview project a chicken ranch in Nuevo will have to be relocated. This project proposes to merge the ranch with a chicken ranch from another location and relocate the enterprise to the corner of Gilman Springs Road and Bridge Street which is located on the southeastern boundary of the San Jacinto Wildlife Area. The location is adjacent to the floodplain of the San Jacinto River and also Mystic Lake. It would house 2.25 million chickens. This would certainly have serious implications for the spread of avian flu. Thousands of migratory waterfowl and shorebirds using Mystic Lake could facilitate the spread of an influenza virus from wild birds to this enormous domestic chicken population. Also of concern are water quality issues since the project will be located adjacent to the San Jacinto River floodplain. The project is still active and going through the planning process. #### MOTTE RANCH (Specific Plan 366) by Ann McKibben:

The Motte Ranch SP hopes to locate 2,200 homes between the San Jacinto Wildlife Area and the Ramona Expressway and is located east of the Villages of Lakeview project along the Ramona Expressway. Dwelling units will be placed adjacent to the floodplain; the project area has serious geotechnical issues such as large ground cracks, soil compaction and proximity to the Casa Loma Fault. HIGHLAND FAIRVIEW LOGISTICS CENTER NOP ISSUED by Sue Nash: In November 2007 the city of Moreno Valley issued a Notice of Preparation of a Draft Environmental Impact Report for the Highland Fairview Logistics Center. The proposed warehouse project site is located on 266 acres in the city of Moreno Valley adjacent to and south of Highway 60 between Redlands Boulevard and Theodore Street. (It is located just north of the San Jacinto Wildlife Area and Lake Perris State Recreation Area.) At build-out, the project would include 2.42 million square feet of warehouse area and 200,000 square feet of commercial/retail area. It would accept 276 incoming cargo containers seven days a week and have approximately 560 outbound truck trips per week. The Friends commented that the project will cumulatively degrade the ability of the San Jacinto Wildlife Area to function as a viable Multi-Species Habitat Conservation Plan (MSHCP) reserve and that a full and detailed analysis of those impacts was required under California Environmental Quality Act (CEQA). The Friends are particularly concerned about: air pollution, night sky light pollution, toxic run-off, availability of water, drainage onto the SJWA (water quality issues), global warming and cumulative impacts of this project. The project would be located a short distance from Moreno Valley's new High School #5. This project is one of three truck distribution centers the city of Moreno Valley is considering to locate along Highway 60 in eastern Moreno Valley. And there is a distinct possibility that the former Moreno Highlands project lands may be converted to commercial/distribution centers. Along with the distribution centers planned for the I-215 corridor, Moreno Valley risks becoming another Mira Loma, an area with major diesel particulate pollution. PROLOGIS PARK NOP ISSUED by Ann McKibben: The city of Moreno Valley issued a Notice of Preparation of a Environmental Impact Report for ProLogis Park, a 2,244,419 square foot industrial center along Highway 60 in eastern Moreno Valley on January 28, 2008. The proposed project is west of the Highland Fairview Logistic Center (HFLC) and would be accessed via Moreno Beach Drive and Redlands Boulevard. The Friends have similar concerns regarding this project as with the HFLC and will be submitting comments to the city. Planner for the project is: Jeff Bradshaw, (951) 413-3224.

QUAIL RANCH NOP ISSUED by Sue Nash and Ann McKibben: The city of Moreno Valley issued a Notice of Preparation of an Environmental Impact Report for the Quail Ranch development on January 31, 2008. The proposed project would place approximately 1,500 units on 1,263 acres of land. The project site is located along Gilman Springs Road, north of Jack Rabbit Trail and is about three miles south of Highway 60. It is outside the city limits but within its sphere of influence. The project area is directly across the road from the north end of Mystic Lake and the San Jacinto Wildlife Area (SJWA). The Quail Ranch Golf Course will be redesigned so the golf course is placed in the Alquist-Priolo Zone of the Claremont Strand of the San Jacinto Fault along Gilman Springs Road.

The Friends commented that this project will cumulative degrade the ability of the SJWA to function as a viable MSHCP reserve and that a full and detailed analysis of those impacts was required under CEQA. The Friends are particularly concerned about: night sky light pollution, water supplies and water quality issues, toxic run-off and drainage onto the SJWA and into Mystic Lake, leap frog development, and cumulative impacts when this project is considered with others. MID COUNTY PARKWAY by Ann McKibben: Plans have been in place for a number of years to expand the Ramona Expressway to a six to eight lane highway from the city of San Jacinto to Corona. The notice of preparation (NOP) was issued for the project, but the Riverside County Transportation Commission (RCTC) had to reevaluate the project alternatives once the state of California declared the Lake Perris Dam was unstable due to seismic concerns. (Federal regulations would not allow a transportation corridor to be built in front of the Lake Perris dam.) Because the project alternatives had to be altered, the RCTC reissued the notice of preparation (NOP) in the summer 2007. The RCTC plans to issue the Draft Environmental Impact Report (DEIR) for the project in April 2008. Some of the concerns the Friends have regarding the project are: impacts on designated MSHCP lands at the SJWA (take of Stephens' kangaroo rat), loss of prime agricultural lands, air & night light pollution, and impacts to the San Jacinto River where the project crosses the river. Eventually, the Friends will produce an annotated list containing detailed information on where the birds can be found, food sources, etc.

#### TO VISIT THE SAN JACINTO WILDLIFE AREA:

**Hours:** The wildlife area is open seven days a week from Dawn to Dusk. You are welcome to visit on your own at any time. There is an Information Kiosk on the east side of Davis Road adjacent to the parking lot.

<u>DIRECTIONS</u> TO THE SAN JACINTO WILDLIFE AREA: San Jacinto Wildlife Area, 17050 Davis Road, Lakeview. Telephone: (951) 928-0580. **DAVIS ROAD IS CLOSED FROM MORENO VALLEY.** Please use one of these alternate routes to visit the San Jacinto Wildlife Area. <u>From Moreno Valley</u>: go south on Perris Boulevard to the Ramona Expressway; go east on the Ramona Expressway to Davis Road in Lakeview; go north on Davis Road 2.3 miles to the headquarters. <u>From Hemet/San Jacinto Area</u>: take the Ramona Expressway west to Davis Road in Lakeview; go north on Davis Road 2.3 miles to the headquarters. <u>From Highway 215</u>: take the Ramona Expressway east to Davis Road in Lakeview (traffic signal); go north on Davis Road 2.3 miles to the area headquarters.

WAIVER FORM: The Friends will be asking all walk participants to sign waiver of responsibility forms. Please be aware that minors (under 18) cannot sign the waiver. The signator must be a parent or other responsible adult.
