OCTOBER IS MEMBERSHIP RENEWAL MONTH:

Every fall we write about how valuable the San Jacinto Wildlife Area is. It is an important link in the Pacific Flyway and provides a stopping point for birds to rest and eat before they continue their migration. Some migrating birds spend the fall and winter months in the northern San Jacinto Valley. The wildlife area began as partial mitigation for the State Water Project; it is a Stephens' kangaroo rat reserve for the Riverside County Habitat Conservation Agency; it is one of a cornerstone reserve in the Riverside County Multi-Species Habitat Conservation system. It is considered one of the premier hunting areas in southern California. Urbanization continues to encroach and threaten the wildlife area. Since 1991, the Friends have worked to advocate for the wildlife area, and have commented on many, many land use and transportation issues. Please take time to renew your membership with the Friends this month and give what you can to help us continue this important work, including the filing of lawsuits such as the one we just won in the court of appeal. SAN JACINTO WILDLIFE AREA News:

WHERE HAVE ALL THE TRIKES GONE?: by Tom Paulek

The MSHCP Biological Monitoring team 2009 Tricolored Blackbird survey this spring (April 23-30) sought to visit all the western Riverside County colony locations reported from the 2005 and 2008 statewide survey efforts. Rose Cook, MSHCP Biologist, reports the only site she found tricolors was the Potrero Unit of the San Jacinto Wildlife Area. First reported in 2005, the Potrero colony comprises 200-300 breeding birds. The San Jacinto Valley was searched extensively and the large historic tricolor colony (8000-10,000 breeding birds) was not found. This is the third consecutive year of no show in the valley of what was only recently the largest remaining tricolor colony in Southern California. In 2006, this colony nested in a dairy wheat field off the Ramona Expressway and has not been seen since. We commend the MSHCP's Rose Cook for her tricolor monitoring efforts. We are concerned, however, the MSHCP adaptive management program as well as the statewide tricolor conservation efforts are long on monitoring but dangerously short on management responses. The Friends are awaiting the release of the UCLA genetic analysis report performed last year on the remaining Southern California tricolor populations.

FRIENDS NEWS & PROJECTS:

THE COURT OF APPEAL RULES IN OUR FAVOR! by

Sue Nash: On June 25th, 2009, the California Court of Appeal in Riverside ruled in our favor and issued an unpublished opinion completely vindicating our position that the Department of Fish and Game and its Wildlife Conservation Board were required by the California Environmental Quality Act (CEQA) to prepare and consider an Environmental Impact Report or other CEQA document before approving and beginning construction of the hunting ponds project at the San Jacinto Wildlife Area in August of 2007. We are seeking a judgment identical to the language in the court of appeal decision: "Consistent with this opinion, respondents (DFG etc.) to (1) vacate and set aside the approval of CWA [California Waterfowl] [grant] application] and (2) not take any further action with respect to the project without first complying with their obligations under CEQA." Friends are also seeking attorney fees. We look forward to enforcing the judgment and notifying you of the comment period for the CEQA document which is now required to be prepared for this project so that it can be properly designed and used to protect the endangered plants and other MSHCP species on the SJWA. In the meantime, we will be discussing with DFG how much the area can be used by the public, especially for waterfowl hunting, without being in violation of the court of appeal decision. A management plan with a CEQA document still has not been prepared for the SJWA.

PROPOSED VILLAGES OF LAKEVIEW SPECIFIC PLAN

342 UPDATE by Ann McKibben: The Riverside County Planning Commission held a 'discuss and continue' meeting regarding the proposed Villages of Lakeview (VOL) Specific Plan 342 on September 16. During the meeting, the Planning Department gave a brief overview of the specific plan. Other departments discussed how transportation and water issues would be handled. Representatives from Lewis Operating Corp also spoke, talking about the benefits of their project. After the presentations the public was allowed to make oral comments on the project. Representatives from the Pechanga Band of Luiseno Mission Indians spoke about the value of the lands as sacred grounds and as a source of their heritage. George Hague submitted and read a joint letter from the Moreno Valley Group of the Sierra Club and the Friends of the Northern San Jacinto Valley. Sue Nash also submitted a letter from the Friends and made comments. Lakeview and Nuevo community members also

made comments on the project. After all the public comments were made the individual planning commissioners asked questions and made comments. Many voiced concerns about the high density of housing units, especially in the project area between the San Jacinto Wildlife Area and the Ramona Expressway. Other concerns that were mentioned were: leapfrog development, availability of water, financial impact analysis based on a 1995 study, village overlay plan (have no idea what villages will look like), loose wording describing how the development would be built over the span of the project, concerns about putting any dwelling units north of the Ramona Expressway, lack of project description in the specific plan. No decision was made on the project and it is scheduled for another Planning Commission meeting on October 21. There is a possibility that more planning commission meetings may be held in January and February to review the project.

The final Environmental Impact Report (FEIR) on the proposed VOL project was released in early September. The document has responses to all of the comment letters submitted on the draft Environmental Impact Report (DEIR). The Friends hired Shute, Mihaly & Weinberger to review the DEIR. On April 21 they submitted a 50 page comment letter to the county planning department outlining detailed concerns regarding the adequacy of the DEIR. The Center for Biodiversity also submitted extensive comments about the project's significant impacts to endangered species and global climate change.

For those who are reading our newsletter for the first time, the proposed Villages of Lakeview project would permit approximately 11,000 residential units in the communities of Lakeview and Nuevo. About 2,800 units are planned next to the southern boundary of the San Jacinto Wildlife Area (SJWA), a 19,000 acre California Department of Fish & Game facility. The SJWA is a cornerstone reserve in the Riverside County Multi-Species Habitat Conservation Plan which is, in theory, supposed to preserve and protect the county's threatened and endangered species in perpetuity. Light pollution, air pollution, feral animals, and illegal entry by residents onto wildlife area lands could potentially harm rare and endangered plant and animal species. It would locate units adjacent to the flood plain of the San Jacinto River. Loss of prime agricultural lands is a major concern. RIVERSIDE COUNTY GENERAL PLAN UPDATE CONTINUES by Ann McKibben:

Riverside County is currently updating its General Plan. The General Plan Advisory Committee (GPAC) has been meeting since the fall of 2008 to discuss updating Policy Areas within the General Plan. The GPAC is composed of interested parties (landowners, developers, water interests) with one representative from the environmental community, George Hague. One of the areas slated for change is called the Northeast Agricultural Conversion Policy Area. The Policy Area includes lands for two proposed but not yet approved specific plans (Villages of Lakeview Specific Plan 342 and the Motte Ranch Specific Plan 366) which are located north of the Ramona Expressway. The policy area continues east along the northern portion of the Ramona Expressway and

ends at Bridge Street in San Jacinto. Although the two specific plans have not been approved by the Riverside County Board of Supervisors, the proposed zoning changes reflect the land uses proposed by each specific plan. It zones land adjacent to the flood plain for residential, it zones land adjacent to the Alquist-Priolo Zone of the San Jacinto Fault (the most active fault in California) as residential, and it zones land on collapsible unstable soils as residential. The GPAC committee met on September 9 to discuss the Northeast Agricultural Conversion Policy Area and voted 8-1 to leave zoning as it currently exists in the General Plan. GPAC members felt they did not have enough information on the environmental impacts to make the changes suggested by the Planning Department. The Policy Area will more than likely be considered by the Riverside County Planning Commission when the General Plan Draft Environmental Impact Report is considered possibly during the first quarter of 2010. MID COUNTY PARKWAY UPDATE by Ann McKibben:

The Riverside County Transportation Commission approved building only half of its planned Mid County Parkway at their July 8, 2009 meeting. Due to environmental issues and a \$3 billion price tag, the commission voted to build only the eastern segment of the project between the city of San Jacinto and Interstate 215 (currently known as the Ramona Expressway). Although residents along the I-215 to Corona segment are relieved that the Cajalco Road will be improved instead of building a separate parallel freeway, many questions remain regarding the eastern segment. The proposed project will have an effect on sensitive and endangered plants and animals at both the San Jacinto Wildlife Area and Lake Perris State Recreation Area. Light pollution, noise pollution, air quality issues are some of the major issues. A portion of the proposed (unapproved) Villages of Lakeview Specific Plan 342 is slated to be wedged between the southern boundary of the San Jacinto Wildlife Area and the northern edge of the Ramona Expressway. This part of the specific plan contains the densest number of units. Freeway ingress and egress will compress the density of the number of units adjacent to the wildlife area. Also no alternative forms of transportation have been proposed such as light rail, buses, car and van pooling. The environmental report will have to be reissued to address the changes in the project. As mentioned previously, many individuals have suggested that the money would be better spent by making modest improvements to the Ramona Expressway, Winchester Road, Highway 74 and Gilman Springs Road instead building a freeway. PROPOSED COMPOSTING FACILITY ADJACENT TO THE SJWA by Ann McKibben:

This spring the project proponent for the McAnally Chicken Ranch withdrew their application for a conditional use permit for a facility to house approximately 2 million plus chickens. Now a private on-site composting facility with storage and sale of green waste materials is being proposed for the former McAnally Chicken Ranch site on the corner of Gilman Springs Road and Bridge Street, Plot Plan No. 24009 – EA42133, APN: 425-080-052. The major concern is the possibility that water in the San Jacinto River and Mystic Lake could be contaminated by runoff from the proposed project. One or more composting facilities are now operating on or adjacent to the this site, and the Friends will continue to monitor all of the composting facilities in or near the San Jacinto River to insure they are fully permitted. PROPOSED HIGHLAND FAIRVIEW CORPORATE CENTER UPDATE by Ann McKibben:

This spring the Sierra Club filed a lawsuit against the city of Moreno Valley challenging their approval of the Highland Fairview Corporate Park project because of the project's health, safety and welfare effects on the city's residents. The lawsuit says that the city did not adequately consider the environmental impacts of the project and did not adequately reduce the effects of the project or consider cumulative impacts of the project. Air quality, traffic, quality of life, noise, availability of water, lack of considering alternatives to the project are other issues covered in the lawsuit. The Highland Fairview Corporate Park project would be a 1.8 million square foot warehouse in eastern Moreno Valley along Highway 60, a short distance from the San Jacinto Wildlife Area. Part of the project would house a Skechers distribution center, one that would distribute their products to the western United States, and would add approximately 2,200 daily diesel truck trips to the already congested Highway 60. The developer apparently is working to modify the city's general plan to make 1,500 acres of the Moreno Highlands Specific Plan into warehouses and logistic centers. If he is successful, traffic on Highway 60 will increase to 40,000 trips a day for polluting diesel trucks. PROPOSED PROLOGIS PARK & RIDGE PROPERTY TRUST PROJECTS, MORENO VALLEY by Ann McKibben:

Two other warehouse/logistics centers are planned for eastern Moreno Valley. The first is ProLogis Park (2 million square feet) along the southern border of Highway 60. There is no new information on the project. The second project is Ridge Property Trust, also along the southern border of Highway 60 in eastern Moreno Valley. It would be a single building of approximately 1 million square feet. The notice of preparation for the project may be circulated in late September with the possibility of a public scoping meeting being held in late October. The city of Moreno Valley is considering numerous plans for warehouses in the city but most are located adjacent to March Air Reserve Base and southern Moreno Valley.

According to information from the California Air Resources Board, the Inland Empire has the worst air pollution in California. The largest source of diesel emissions in the South Coast Air Basin, which includes Riverside and San Bernardino counties, is the goods-movement industry and its associated warehouse distribution centers. Riverside County

is the first in the nation for asthma, heart disease and respiratory ailments.

PROPOSED QUAIL RANCH SPECIFIC PLAN, MORENO VALLEY by Ann McKibben:

There is no new information on the proposed Quail Ranch Specific Plan. The specific plan area is located along Gilman Springs Road (about three miles south of Highway 60) across the road from Mystic Lake. The project would put approximately 1,500 units on 1,263 acres of land. The land is not within the city limits of Moreno Valley but is within their sphere of influence. Planner for this project is Jeff Bradshaw, (951) 413-3224.

at facilities throughout the state are used to manage wildlife habitat throughout the state.

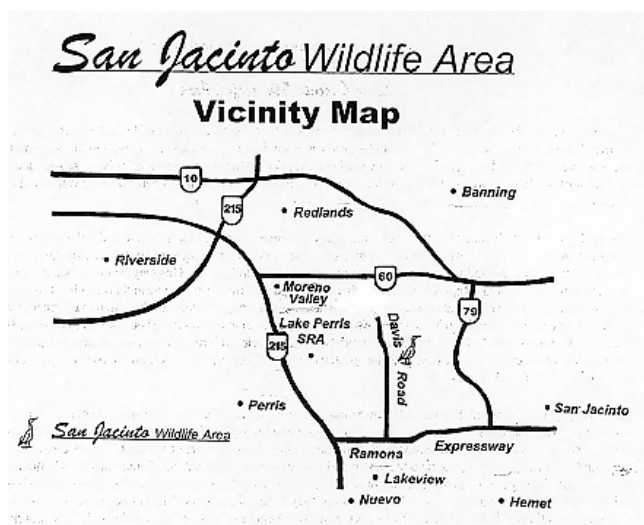
Waterfowl Hunting: *October 24, 2009 through February 6, 2010*; There will be ALL DAY waterfowl hunting on all Wednesdays and Saturdays. The Wetland Areas at the San Jacinto Wildlife Area will be closed ALL DAY ON WEDNESDAY AND SATURDAYS for non-hunting public use during the waterfowl season.

Pheasant Hunting: *November 15 (Sun) and November 16, 23, 30 and December 7, 14, 21, 2009 (ALL Mondays)*, there is ALL DAY pheasant hunting throughout the wildlife area on the Mondays listed.

Please keep these dates in mind when you schedule your visits to the wildlife area and call the area staff at (951) 928-0580 during regular office hours (6:30 a.m. to 3:00 p.m.) if you have any questions regarding the closed areas.

DIRECTIONS TO THE SAN JACINTO WILDLIFE AREA: San Jacinto Wildlife Area, 17050 Davis Road, Lakeview. Telephone: (951) 928-0580. **DAVIS ROAD IS CLOSED FROM MORENO VALLEY.** Please use one of these alternate routes to visit the San Jacinto Wildlife Area. *From Moreno Valley:* go south on Perris Boulevard to the Ramona Expressway; go east on the Ramona Expressway to Davis Road in Lakeview; go north on Davis Road 2.3 miles to the headquarters. *From Hemet/San Jacinto Area:* take the Ramona Expressway west to Davis Road in Lakeview; go north on Davis Road 2.3 miles to the headquarters. *From Highway 215:* take the Ramona Expressway east to Davis Road in Lakeview (traffic signal); go north on Davis Road 2.3 miles to the area headquarters.

PLEASE USE CAUTION WHILE DRIVING ON DAVIS ROAD IF THERE HAVE BEEN RECENT RAINS. *Do not drive on Davis Road if it is muddy or it is raining. During the rainy season, please call the wildlife area headquarters, (951) 928-0580, during regular office hours (6:30 a.m. to 3:00 p.m.) to ask about road conditions.*
